CATEGORIES & CRITERIA

Public Health Research Award

To be eligible for the Research Award, the abstract must report on a research project that is completed, or a completed section of a program of research, and that has ethical approval, or quality improvement (minimal risk) approval or is a systematic review or a quality improvement project.

Abstracts to be considered for the Public Health Research Award:

- Abstract Title (maximum of 12 words)
- Maximum of 250 words;
- Background/Context;
- Method/Process;
- Results/ Analysis;
- Conclusion/ Outcomes
- Implications for public health
- Translation to policy and/or practice change
- Identify 2-3 learning objectives significant to the presentation

Advocacy & Leadership Award

The Advocacy and Leadership Award is presented to the best paper which presents on public health advocacy and leadership in one of the following areas:

- Leadership and ethics;
- Health equality;
- Social mobilisation and solidarity;
- Public education;
- People centric;
- Engagement;
- Communications; and
- Ecologically sustainable development.

To be eligible for the Advocacy and Leadership Award, presentations must showcase how their research, policy or practice has influenced decisions within political, economic, and social systems and institutions through effective leadership and messaging.

Early Career/Young Professional Award

The Early Career/Young Professional Award is presented to the individual who is a young professional or early in their public health career. The presenter must be the first author on the presentation and the main presenter.

- Abstract Title (maximum of 12 words)
- Maximum of 250 words;
- Background/Context;
- Method/Process;
- Results/ Analysis;
- Conclusion/ Outcomes
- Implications for public health

First Time Presenter Award

The First Time Presenter Award is presented to the individual who has never presented at a conference with more than 250 delegates before. You will be presenting for the first time outside of their organisation/ place of work/tertiary institution. The presenter must be the first author on the presentation and the main presenter.

Abstracts to be considered for the First Time Presenter Award:

- Abstract Title (maximum of 12 words)
- Maximum of 250 words;
- Background/Context;
- Method/Process;
- Results/ Analysis;
- Conclusion/ Outcomes
- Implications for public health
- Translation to policy and/or practice change
- Identify 2-3 learning objectives significant to the presentation

Best Poster Award

All posters are eligible for the Best Poster Award and will be assessed against the following criteria:

- Contribution to public health knowledge is demonstrated
- Contribution to public health practice is demonstrated
- Visually appealing, legible font and not crowded
- Content is clear, concise and original
- Relevance to public health and implications for public health advocacy and practice is shown

Abstracts to be considered for the Best Poster Award should include:

- Abstract Title (maximum of 12 words)
- Maximum of 250 words;
- Background/Context;
- Method/Process;
- Results/ Analysis;
- Conclusion/ Outcomes
- Implications for public health
- Translation to policy and/or practice change
- Identify 2-3 learning objectives significant to poster

Award Marking

The abstract awards will be reviewed during the Australian Public Health Conference by appointment reviewers by the Conference Advisory Committee. Each award will have 5 finalists who will be marked against 5 criteria graded between 1-5, from the scores an average mark will be calculated and ranked against the other presentations to determine the successful presentation.
